ORDER

1. The Admission Supervisory Committee, herein after referred as ASC, through communication referred as 1st paper above, has directed the Principal, Vimal Jyothi Engineering College, Chemperi, Kannur in short the College, to produce the list and supporting documents of the admitted candidates in respect of

B.Tech Course for the academic year 2019-20 on 23.09.2019 at 10.00 AM.

- **2.** Accordingly, the Principal has deputed Mr. Shaji Scaria, Office Assistant of the Engineering College to appear before the Committee with the list and supporting documents in respect of the admitted candidates for B.Tech Course 2019-20
- **3.** The College is one of the Member Colleges of the Kerala Catholic Engineering College Managements' Association (KCECMA). The KCECMA submitted the Common Prospectus on 02.05.2019 for approval of ASC. The Admission Supervisory Committee scrutinised the same and provisionally approved the Common Prospectus through communication 2nd Paper referred above.
- **4.** The ASC scrutinised the documents submitted by the College and found that the School of Engineering is having intake strength of Five Hundred and Forty (540) seats under different branches. The College has submitted the AICTE Extension of Approval order and the Extension of Provisional affiliation order issued from the KTU for the Academic Year 2019-20, for conducting the above course.
- **5.** The Committee scrutinised the list and supporting documents submitted by the College and found that the College has admitted Four Hundred and Three (403) candidates. The college has admitted One Hundred and Fifty Eight (158) under Government quota, One Hundred and Fifteen (115) candidates under Management Quota Seats, Seventy Seven (77) NRI candidates, Forty Five (45) candidates

under Merit Lapsed NRI and Five (05) candidates under Merit Lapsed Management seats under different branches of B.Tech.

- **6.** The Committee scrutinised the documents submitted by the College and found that the One Hundred and Fifteen (115) candidates are admitted under Management Quota. ie Twenty Two (22) candidates under Civil Engineering branch, Thirty Eight (38) candidates under Computer Science Branch, Sixteen (16) candidates under Electronics Communication Engineering, Eleven (11) candidates under & Electrical & Electronics Engineering branch, Twenty Two (22) candidates under Mechanical Engineering branch and Six (06) candidates under Applied Electronics and Instrumentation Engineering branch. The ASC scrutinised the list and supporting documents and found that the documents of the above One Hundred and Fifteen (115) candidates are acceptable and are eligible for admission under Management Quota. Therefore, the admissions of the above One Hundred and Fifteen (115) candidates admitted under Management Quota are hereby approved, as per the list shown as Annexure I.
- 7. The ASC also scrutinised the list and documents of Seventy Seven (77) candidates admitted under NRI quota, ie Eighteen (18) candidates under Civil Engineering branch, Fourteen (14) under Computer Science Branch, Thirteen (13) candidates under Electronics & Communication Engineering, Nine (9) candidates under Electrical & Electronics Engineering branch, Eighteen (18) under Mechanical Engineering branch and Five (05) candidates under Applied Electronics and Instrumentation Engineering branch and found that the documents submitted by the College are proper and acceptable for

admission to NRI Category. Therefore, the admissions of the above Seventy Seven (77) candidates admitted under NRI category are hereby approved, as per the list shown below as Annexure II.

- 8. The College has also admitted **Five (5)** candidates under Government Lapsed Management Quota seat ie Two (02) candidates in Civil Engineering and Three (03) candidates under Computer Science Branch. The ASC scrutinised the list and documents and found that the admissions made by the college are proper and the documents are acceptable and eligible for admission under Government Lapsed Management Quota seat. **Therefore, the admissions of the Five (05)** candidates admitted under Government Lapsed Management seats are hereby approved as per the list shown as Annexure III.
- 9. The College admitted **Forty Five (45)** candidates under Merit Lapsed NRI Seat ie Eighteen (18) candidates in Civil Engineering Branch, Fourteen (14) Candidates in Computer Science Branch, Thirteen Candidates (13) candidates in Electronics & Communication Engineering, Nine candidates (09) in Electrical and Electronics branch, Eighteen candidates (18) in Mechanical Engineering Branch and Five (05) Candidates in Mechanical Engineering Branch. Clause 2.16 (j) of the AICTE Approval Process Handbook 2019 would read,

"Besides this, any vacant seat in the "Approved Intake" after the last round of the admission of the Concerned State Government/UT, may be filled with NRI/Foreign Nationals/Overseas Citizen of India (OCI)/Persons of Indian Origin (PIO)/Children of Indian Workers in the Gulf Countries, subject to the approval from AICTE for the above seats and fulfilment of requisite norms as specified in the Approval Process Hand Book."

- **10**. On the basis of the above provision in the AICTE Approval Process Hand Book, the Government issued GO (Rt) No.1442/2018/H.Edn dated 25.07.2018 wherein it is stated that,
 - "If any College is granted permission by the All India Council for Technical Education (AICTE) to admit students under NRI and /or PIO/OCI/FN, then on completion of the allotment process by the Commissioner for Entrance Examinations, if any seats are lying vacany, those seats could be filled with the candidates belonging to NRI/PIO/OCI/FN. However the Colleges shall not admit any students in excess than the approved intake(for Colleges having approval for OCI/PIO/FN, the total admissions shall not exceed approved intake + 15% supernumerary"
- 11. In the light of the above provision in the AICTE Approval Process Hand Book and GO (Rt) No.1442/2018/H.Edn dated 25.07.2018, the admissions of the above Forty Five (45) Merit Lapsed NRI Candidates are hereby approved. The list of approved Merit Lapsed NRI candidates is shown below as Annexure IV.
